- A. NCFI ENDURATECH[®] Premier Roofing System (Barnhardt Manufacturing Company dba NCFI Polyurethanes) warrants to the Building Owner all products purchased to be free of defects at time of sale and to meet published physical properties when applied, cured and tested in accordance with NCFI's standard procedures for quality control. NCFI's sole liability is limited to any NCFI product shown to be otherwise than warranted for 10 years from date of application. This Warranty is expressly conditioned upon Building Owner's obligation to have the product applied in strict accordance with NCFI's current published instructions covering surface preparation, product application and precautions.
- B. This Warranty is expressly conditioned upon:
1. The Owner's obligation to notify NCFI within five working days of the date that Owner discovers a defect. NCFI shall then have the right to immediately inspect the defect, and if not given this right, the Warranty shall be terminated.
 2. NCFI shall not be responsible for repairs made by others who are not authorized by NCFI to make such repairs.
- C. This Warranty does not cover failure of the product due to:
1. Damage to the product due to improper handling or storage after shipment.
 2. Damage to the product, property, building or contents caused by fire, settlement, faulty construction or design, movement, misuse of structure, or other failure of the structure.
 3. Damage to the product due to natural causes, including but not limited to floods, lightning, hail, cyclones, full gale, hurricanes, tornadoes, earthquakes, or other extraordinary or unusual events.
 4. Damage to the product resulting from cracks or openings in the roof substrate.

- 5. Improper preparation or defects in the substrate, errors in the roofing system, or any other latent defects.
 - 6. Vandalism, penetration or damage caused by third parties or foreign objects or agents, including plant or animal life.
 - 7. Damage caused by repairs or alterations to, encroachment upon or erection of structure on the roof or any use of the roof other than for its intended purpose at the time the Warranty was issued.
 - 8. Color changes in the product as the result of normal weathering or atmospheric conditions.
- D. NCFI WILL NOT BE LIABLE FOR ANY DIRECT, INDIRECT, CONSEQUENTIAL, INCIDENTAL, SPECIAL, OR GENERAL DAMAGES OF ANY KIND FROM WHATEVER CAUSE WHICH MAY ARISE AS THE RESULT OF DETERIORATION OF SAID PRODUCT, EXCEPT TO SUPPLY ALL NCFI PRODUCT IN ACCORDANCE WITH THE WARRANTY. IT IS EXPRESSLY UNDERSTOOD AND AGREED THAT NCFI SHALL IN NO WAY BE DEEMED OR HELD TO BE OBLIGATED, LIABLE, OR ACCOUNTABLE UPON OR UNDER ANY GUARANTEES OR WARRANTIES, EXPRESS, OR IMPLIED, INCLUDING ANY IMPLIED WARRANTY OR MERCHANTABILITY OR FITNESS FOR A PARTICULAR USE, OR OTHERWISE BEYOND THIS EXPRESS WARRANTY.
 - E. Neither the issuance of the Product Warranty, nor any examination or inspection of the building or the plans and specifications thereof by NCFI representatives or distributors, before or after completion of the roof system shall constitute approval of same or a waiver of any of the exclusions and/or conditions set forth herein.
 - F. NCFI's obligation shall commence upon receipt of full payment of the Warranty to NCFI and full payment of material to NCFI and an approved final project inspection report. If such payments for warranty and materials are not received within 30 days of the execution date hereof, all such Warranty obligations shall be permanently voided. No third party shall be an agent of NCFI for receipt of such payment and inspection report.
 - G. Owner's signature constitutes acceptance of all terms and conditions of this warranty.
 - H. This Warranty shall be interpreted according to the laws of the State of North Carolina.
